Vendors hereby contract for exhibit space at Hardyston Day on June 11, 2011 and will abide by the following rules:

1. Vendors must exhibit crafts from 12 PM until 5 PM.
2. Set up time: No earlier than 8:30 AM - Spaces ready by 10:30 AM - Clean up time after 5 PM
3. Vehicles may be unloaded at exhibit site, but must be parked in designated area, during the event.
4. ONLY HANDCRAFTED OR NEW ITEMS CAN BE OFFERED FOR SALE. There will be a walk-through prior to start time to confirm displayed goods are as contracted for (no garage sale items please).
5. Vendors must bring their own table & chair. If possible, the craft table should be covered to the ground so that extra items can be stored underneath and out of sight. No goods can be displayed in the aisles beyond the designated exhibition area and spaces cannot be enlarged or altered. It is advisable to bring a canopy for protection from the sun or showers.
6. Vendors will be responsible for any damage to designated area, property, or persons due to neglect or wrongdoing.
7. The Township of Hardyston will not be responsible for any loss or damage suffered by vendors during or after Hardyston Day.
8. Vendors should submit a photo depicting a sample of their craft(s) when returning this application (photos will not be returned). Vendors will consider their needs carefully before submitting this Contract.
9. Spaces must be reserved and paid in full by June 3rd, 2011. This rental fee is Non Refundable.
** We reserve the right to limit the number of businesses, crafters or vendors in any particular category and work on a first come-first serve basis.
