



# BULKY WASTE COLLECTION PROGRAM – OCTOBER 3 THROUGH 6

The Township of Hardyston will conduct a residential bulky waste pick up program  
**October 3<sup>rd</sup> THROUGH 6<sup>TH</sup>.** Registration with the Township is required.

- A **minimum fee of \$60 (\$50 for senior citizens)** per household includes the pickup of 750 pounds of acceptable material including one large appliance (refrigerator stove, etc.) - **OR** - piece of furniture (sofa, dresser, etc.). Please note, refrigerators, air conditioners, dehumidifiers placed out for collection must be certified to be free of Freon. **NOTE: the Township will pick up an appliance that is not Freon free for an additional fee of \$10 per item to cover the SCMUA charge for Freon removal.**
- **For each additional large appliance/furniture piece an additional \$10 fee (except refrigerators - \$15) will be charged.**
- **A separate fee for tires will be charged as follows: \$2.50 per car tire; \$4 per truck tire.**

**Materials for pickup must be placed at the roadway, NO LATER THAN 6:00 AM, TUESDAY OCTOBER 3<sup>rd</sup>.** Mail or bring registration form and payment to Hardyston Township Municipal Office, 149 Wheatsworth Road, Hardyston, New Jersey 07419. **Registration Form must be received by FRIDAY, SEPTEMBER 29<sup>th</sup>.**

**ACCEPTABLE MATERIALS:** White goods, furniture, carpets/rugs, metal sheds (flattened), lawn furniture, non-riding lawn mowers (fuel removed), small auto parts, books, bookcases, barbecue grills (tanks removed), small appliances, toys, clothing, tools, home accessories, doors/windows, pools (flattened), hot water heaters, small fixtures, etc.

**UNACCEPTABLE MATERIALS: ELECTRONICS,** Paint cans, pesticides, herbicides, paint thinners, driveway sealant, gas/propane canisters, riding mowers, auto batteries, construction debris, leaves, pool chemicals, photo chemicals, junk cars/trucks, tree stumps, food waste, motor oil, furnaces, fuel tanks, explosive/flammable material, demolition material, recyclable material. **REFUNDS WILL NOT BE ISSUED.**
