## A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE HARDYSTON TOWNSHIP MUNICIPAL UTILITIES AUTHORITY AUTHORIZING CHANGES TO THE WATER AND WASTEWATER SERVICE RATES PURSUANT TO AND IN ACCORDNACE WITH N.J.S.A. 40:14B-1 et. seq.

WHEREAS, the Hardyston Township Municipal Utilities Authority (the "Authority") owns and operates a water supply system and wastewater collection system servicing a portion of the residents and businesses of Hardyston Township (collectively, the "System"); and

WHEREAS, the Authority's Rules and Regulations Section II set forth the rates that the Authority charges its customer for water and wastewater services ("Rates"); and

WHEREAS, in compliance with the requirements of N.J.S.A. 40:14B-1 et seq., the Authority properly noticed the public that it intended to consider and discuss an increase to its Rates; and

WHERESA, at its regularly scheduled monthly Board meeting on September 12, 2022, the Authority held a public hearing concerning the proposed changes to its Rates; and

WHEREAS, the proposed changes to the Authority's Rates are necessary and proper for the smooth and efficient operation of the System and to allow the Authority to provide necessary services to its customers; and

NOW, THEREFORE, BE IT RESOLVED by the Board of the Hardyston Township Municipal Utilities Authority as follows:

1. The proposed changes to the Rates, attached hereto as Exhibit A, are hereby adopted as the Authority's new Rates for water and wastewater services and shall be effective on October 1, 2022; and
2. This Resolution shall take effect upon adoption.
