MINUTES HARDYSTON TOWNSHIP MUNICIPAL UTILITIES AUTHORITY JUNE 4, 2018

The meeting of the Hardyston Township Municipal Utilities Authority was held on Monday, June 4, 2018 at 7:00 p.m., at the Municipal Building located at 149 Wheatsworth Road. Members present were Mr. Kula, Mr. Marples, Mr. Roof, and Ms. Van Allen. Also present were Marianne Smith, Carrine Kaufer, Bob Schultz, Mike Vreeland and Ryan Scerbo.

After a salute to the flag, Mr. Kula stated compliance with the Open Public Meetings Act.

MINUTES: A MOTION was made by Marples, seconded by Roof to approve the minutes of the May 7, 2018 meeting. In favor, Kula, Marples, Roof and Van Allen.

Shotmeyer Tract/ Bypass- Marianne Smith stated that the Shotmeyer tract has a new purchaser. Meetings with the Township's professionals have taken place and the buyer was advised of the need for the bypass to be completed.

Water Tank – nothing new to report.

Irrigation – Mike Vreeland stated that the NJDEP application had been submitted. Once approval has been received the system can be installed.

Ridgefield Commons Emergency Interconnection – Nothing new at this time

Operational Considerations / Metering / Strategic Planning — Carrine stated that the HTMUA received written approval from the New Jersey Infrastructure Bank for a loan up to \$100,000 for the Asset Management Plan. The HTMUA has 90 days to close the loan. Mike Vreeland will begin work on the plan as soon as possible. William Mayer, Bond Counsel, will have the Bond Resolution ready for the August meeting. Carrine added that following the approval of the Asset Management Plan they will begin working on obtaining the NJIB financing for the water tank repairs.

A RESOLUTION OF THE HARDYSTON TOWNSHIP MUNICIPAL UTILTIES AUTHORITY AUTHORIZING AMENDMENTS TO THE RULES AND REGULATUONS OF THE AUTHORITY

WHEREAS, the Hardyston Township Municipal Utilities Authority (the "Authority") owns and operates a water supply system and a wastewater conveyance system servicing the residents of Hardyston Township (collectively the "Systems"); and

WHEREAS, at its regularly-scheduled Board meeting of May 7, 2018, the HTMUA considered and discussed proposed modifications to its Rules and Regulations with regard to updating and revising the following sections of its Rules and Regulations:

- 2.1.3 Potable Water Irrigation of Common Areas Rate; and
- 2.1.4 Bulk Water Purchase Rate (collectively the "Amendments");

WHEREAS, at its regularly scheduled Board meeting on June 4, 2018, the HTMUA held a public hearing concerning the Amendments; and

WHEREAS, the Amendments are necessary for the efficient operation of the Systems and to allow the HTMUA to provide necessary services to its customers; and

NOW, THEREFORE, BE IT RESOLVED by the Board of the Hardyston Township Municipal Utilities Authority as follows:

- 1. The proposed amendments are reasonable and necessary inasmuch as they properly update fees and general information, and are hereby adopted, effective June 4, 2018, as set forth in the redlined proposal attached hereto as Exhibit A, and such changes shall be reflected in the Rules and Regulations.
- 2. That this Resolution shall take effect upon adoption.
