1st READI<u>NG</u>: 2015-15

AN ORDINANCE OF THE TOWNSHIP OF HARDYSTON, COUNTY OF SUSSEX, AND STATE OF NEW JERSEY TO ACQUIRE BLOCK 63, LOT 27.06 FROM CJS INVESTMENTS

WHEREAS, the Local Lands and Buildings Law, <u>N.J.S.A</u>. 40A:12-1 *et seq.*, provides that a municipality may, by ordinance, provide for the acquisition of real property or an interest therein by purchase, gift, devise, lease, exchange, or condemnation in the manner provided in the Eminent Domain Act, <u>N.J.S.A.</u> 20:3-1 *et seq.*; and

- **SECTION 2.** The said land to be conveyed to the Township of Hardyston is shown on Schedule A which is attached hereto and made a part hereof.
- **SECTION 3**. The Mayor and Township Clerk and all other proper officers and employees of the Township are hereby authorized and directed to take any and all steps necessary to effectuate the purposes of this ordinance.
- **SECTION 4**. No debt is to be authorized by the enactment and passage of this ordinance.
- **SECTION 5**. All ordinances of the Township of Hardyston, which are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.
- **SECTION 6**. If any section, subsection, sentence, clause or phrase of this ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this ordinance.
- **SECTION 7**. This ordinance shall take effect immediately upon final passage, approval, and publication as required by law.

WHEREAS, the Lake Gerard Dam was in serious need of rehabilitation, including Main Dam, Principal Spillway and Dike B; and

WHEREAS, the project shall include completion of engineering investigations and design necessary to complete plans and specifications, construction of the project as well as construction inspection services; and

WHEREAS, Lake Gerard LLC timely applied for a loan pursuant to the 1992

Dam Restoration and Inland Waters Projects Loan Program ("Loan Program"); and

WHEREAS, the application for the loan was approved by the New Jersey

Department of Environmental Protection; and

WHEREAS, pursuant to the Loan Program terms Lake Gerard LLC is required to have the Township act as a co-borrower; and

WHEREAS, Lake Gerard LLC and the Township have agreed to the terms of a co-borrower agreement to be incorporated into the loan agreement; and

WHEREAS, as a condition of entering into the co-borrower agreement, the Township required that Lake Gerard LLC establish an escrow account in the amount of \$200,000 as a form of collateral in the event of Lake Gerard LLC's default on repayment of the loan agreement; and

WHEREAS, the Mayor and Township Council believe it is in the best interests of the Township and the Lake Gerard community to enter into these agreements in order to ensure completion of the dam rehabilitation project.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Township Council of the Township of Hardyston, County of Sussex, State of New Jersey that the Township shall execute and enter into the loan agreement with Lake Gerard LLC and the NJDEP

for an amount not to exceed \$1,746,323.00 for the restoration of the Lake Gerard Dam; and

BE IF FURTHER RESOLVED that the Township shall execute and enter into the required co-borrower agreement with Lake Gerard LLC for an amount not to exceed \$1,746,323.00 for the restoration of the Lake Gerard Dam.
