A RESOLUTION OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF HARDYSTON, COUNTY OF SUSSEX AND STATE OF NEW JERSEY TO ACCEPT THE PROPOSAL SUBMITTED BY ZITONE CONSTRUCTION & SUPPLY CO., INC. AS THE LOWEST RESPONSIBLE BIDDER FOR PERFORMANCE OF THE FIREHOUSE EXPANSION 2016 PROJECT, INCLUDING ALL ALTERNATES

**WHEREAS,** pursuant to authorization by the Mayor and Township Council of the Township of Hardyston, the Township received sealed competitive bids for the performance of the firehouse expansion project, including all alternates; and

WHEREAS, in response to the "Notice to Bidders" the Township received four (4) bids; and

**WHEREAS**, said bids have been duly reviewed and analyzed by the Director of Public Works, architect Charles Schaffer and the Township Attorney; and

WHEREAS, the bid received from the lowest responsible bidder, Zitone Construction & Supply Co., Inc., has been found to be substantially in proper form and in compliance with the provisions of N.J.S.A. §40A:11-23.5 and the specifications as written; and

**WHEREAS**, the Chief Financial Officer has certified as to the availability of funds and encumbrances for this purchase shall come from account Ordinance #2014-14.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Township of Hardyston, County of Sussex, State of New Jersey, the following:

- 1. The Township Council hereby awards a contract to Zitone Construction & Supply Co., Inc. in an amount not to exceed \$700,000.00.
- 2. The Mayor and Township Clerk are hereby authorized and directed to execute a contract for a total amount not to exceed of \$700,000 to Zitone Construction & Supply Co., Inc., in accordance with its bid for the performance of the firehouse expansion project, including all alternates.
- 3. The Township's Chief Financial Officer has certified the availability of funds for same.
- 4. This resolution and contract shall be available for public inspection in the office of the Township Clerk.

This Resolution shall take effect immediately.

# A RESOLUTION OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF HARDYSTON, COUNTY OF SUSSEX AND STATE OF NEW JERSEY AUTHORIZING THE TRANSFER OF A SOIL REMOVAL LICENSE FROM SHOTMEYER BROTHERS, INC. TO BEAVER RUN FARMS, INC.

WHEREAS, the Mayor and Council authorized a Soil Removal License to Shotmeyer Brothers, Inc. with respect to Block 69, Lot 2.01 on January 13, 2016; and

- 1. The Soil Removal License issued to Shotmeyer Brothers, Inc. regarding Block 69, Lot 2.01 is hereby approved to be transferred to Beaver Run Farms, Inc. subject to the same conditions, requirements and obligations, including but not limited to the Hardyston Township Code.
- 2. This transfer is subject to Beaver Run Farms, Inc. posting all required Restoration Bonds in accordance with the Township Code prior to the transfer of the subject Soil Removal License.
