- All applications MUST include: a Food Handlers Permit from the Township of Hardyston, Temporary Retail Food Vendor Application through County of Sussex, as well as a copy of current Sanitary Inspection Certificate, and a Certificate of Insurance with minimum of \$1,000,000.00 naming "Township of Hardyston" as certificate holder.
- If you do not have a current Food Handlers Permit from the Township of Hardyston, please contact the Health Department at: 973-823-7020 x9402. **Additional fees may incur.**
- Retail Food Vendor Application with County of Sussex: Application is available on-line www.sussex.nj.us. Go to form center and proceed to Department of Environmental and Public Health Services - *Application: Farmers' Market/ Temporary Event Coordinator and Farmers' Market /Temporary Event Food Vendor List*
- Vendors will supply their own power source. Electric is NOT available.
